Claim up to 33%* of your R&D costs (13% for RDEC) in tax credits when developing a new process, product or service, or even improving an existing one.

CREATIVE INDUSTRIES TAX RELIEFS

Video Games companies, Museums, Galleries, Orchestras & Theatres can claim a significant reduction on their taxable profits. They're applicable if they have designed, produced and tested a video game, produced and run a limited-time exhibition at a venue, staged a dramatic production with a live audience, or staged an orchestral concert with 12 performers or more.



RESEARCH AND DEVELOPMENT ALLOWANCES

Claim up to 100% tax relief on your capital expenditure on qualifying R&D activities. There is no limit to the amount you can claim, unlike the annual R&D investment allowance.



ENERGY TAX EXEMPTIONS

Through the Energy-Intensive Industries (EII) & Climate Change Levy (CCL) schemes, eligible energy-intensive businesses can apply for compensation for a proportion of the costs of their total energy bills.



CAPITAL ALLOWANCES

Claim valuable tax relief on qualifying capital expenditure incurred when buying equipment or buildings, or carrying out new construction, refurbishment or fit out works.



LAND REMEDIATION RELIEF

We help developers claim back a significant portion of the costs incurred when cleaning up purchased land in a contaminated or derelict state.

*NOTE: These are effective for expenditure incurred up until 1st April 2023. The new rates of relief post 1st April 2023: up to 27% for R&D intensive loss-making SMEs (20% for RDEC)
