# **Executive Summary**

2021 has been an interesting year. It has been punctuated by the continued adaption to the unprecedented Covid-19 pandemic, which has provided a global disruption that altered all our lives. Luckily, for the United Kingdom, life is returning to normal and at a considerable pace. We appear to have weathered the short-term impacts of the pandemic with national lockdowns ending, face to face meetings starting and the majority of the population being vaccinated.

At the FIA, we are proud to have played our role in helping the fire industry not only survive the pandemic but thrive throughout its duration, by securing key worker status and transitioning to online training to name but a few. In spite of the pandemic, key industry issues such as the response to the Grenfell tragedy and Brexit remained of paramount importance to the industry - much like the last few years we have prioritised these issues to ensure that we as an industry are able to put our best foot forward.

Over the last year, we have worked tirelessly with our members and the wider fire industry to continue the progress that has been made across the board to ensure that our industry is safer, our members are stronger and our association is better.

Amongst a diverse range of actions in our response to the Grenfell tragedy, the FIA has continued to take a primary focus on life safety. We had great success in the creation and application of the Building Safety Information Portal (BSIP). Following the Grenfell tragedy, External Wall Survey-1 (EWS-1) forms were developed as a means of enabling competent fire experts to aid lenders and sellers to value flats in high rise buildings, by identifying if remedial work needs to be carried out. We have fully funded

the BSIP and employed software specialists to create an effective, efficient, and user-friendly website that is supported by the Royal Institution of Chartered Surveyors (RICS) Forum. This has allowed the FIA to effectively manage and verify the validity of EWS-1 forms; as well as the individuals uploading the forms. The public is free to search for forms via postcode. We have employed a rigorous approach to the BSIP to include manual checks at various stages of the process in order to eliminate, as far as possible, the current problem of fraudulent EWS-1 forms appearing in the market and to ensure that forms are completed by those sufficiently competent to do so.

As a result of the Grenfell tragedy, it is no surprise that the government are implementing the recommendations of the inquiry and changing and creating new legislation. Our technical team, Councils and Working Groups have spent the last year working with the Government and key stakeholders to provide advice and support on: the Grenfell Report, the Building Safety Bill, the Fire Safety Bill and the Personal Emergency Evacuation Plan (PEEP) consultation.

In addition, we have published a Code of Practice in collaboration with the National Fire Chiefs Council (NFCC) on Premises Information Boxes (PIBs) and started another SIG with the Institution of Fire Engineers (IFE) on Facades.

Brexit has continued to pose new, unique and complex challenges to our industry, whether that be a skills shortage, export and import issues or regulatory and standards concerns. Our Brexit Report published in early 2021 highlighted that the biggest concern of the overwhelming majority of our members and the industry was the UKCA mark.

We have been in constant communication with the Government over the last year voicing the concerns of the fire industry through our UKCA SIG on the impact of implementing the new UKCA mark. It has been a priority to relay to the Government the impact that changing to the UKCA regime will have for the overwhelming majority of our members whose task it is to keep buildings safe; but also, for the thousands of business owners that rely on their buildings being compliant so that they can remain open.



We have extensively lobbied to extend the transition period that our industry has been given and we are pleased that the Government has listened and has granted a one-year extension for UK products to continue using the EU's "CE" safety mark which we hope will give our members more time to transition to the UKCA mark.

Beyond the UKCA mark, our Export Council has a permanent agenda item on Brexit that provides a forum for raising and discussing post-EU issues. The FIRESA Council provided advice to the Fire and Rescue Services on maintenance of the supply chain in the transition period and post-Brexit. Finally, our website and LinkedIn profile with over 29,000 professionals became the hub for Brexit where we share key information such as the Brexit International Trade Checklist.

What's more, we have been working with the Department for International Trade by attending their fortnightly Business Organisation meetings run by UK Defence and Security Exports and other sector trade associations which has enabled an exchange of views and information from the two sets of parties. This forum provides us with a vitally important opportunity to raise our member's concerns with Brexit at the highest level.

Whilst it is unclear what the actual impacts of Brexit will be in the years to come, one thing is clear, the FIA will continue to be the voice of the fire safety industry and through doing so, give our members the best chance to ensure that Brexit can have a net positive effect on our industry. As our 2020 Annual Report stated 'with adversity comes innovation and we at the FIA are no different in the way we have had to adapt'. To adapt to the lockdown, we transitioned to online training and in 2021 we have worked incredibly hard to fine-tune our online training service.

Beyond improving the quality, we have also increased the number of training courses that are available for fire professionals across the UK and the world that can be taken online. With 24 of our 28 industry-leading training courses now available online which is 11 more online courses than last year - this gives fire professionals more freedom to take their training online or in class. Over the last 12 months, we have already introduced 3 new courses namely: 'BS 5839-6 Fundamentals in FD&A Systems', 'Evacuation and Alert Systems to BS 8629' and 'Fire Protection for Electronic Equipment



Installations to BS 6266', which have been well received and bookings are strong. Another course is set to release in quarter 4 of 2021 titled 'Emergency Voice Communication to BS 5839-9'. We have also expanded and improved our 'Unit 7: Active Fire Protection Systems' course to cover more content than before.

Other big news; after the sale of our Awarding Organisation (AO) to BAFE in August last year, we maintained our AO status until this July when BAFE's FireQual gained its own AO recognition. Over this period, we not only acted as both a training provider and AO but also assisted FireQual in the development of its operation and successful establishment as an AO. The primary aim of both ourselves and FireQual has been to ensure an effective and smooth transition for all learners, including those that are partway through the modules necessary to achieve their qualification. We believe we have succeeded in this important goal and are equally pleased that our activity as a FireQual-recognised Training Centre continues to flourish.

Our membership has mirrored training's expansion as over the last 12 months we have seen the largest number of companies coming into membership in the history of the association. With 161 new members, we have seen a 100% increase in membership growth compared to 2020. We have a long-standing target of reaching 1,000 member companies with expectations that we will achieve this by the end of September 2021. Throughout the last year, we have been working on a number of initiatives to continuously improve our offering to our members such as our partnership arrangements in a number of areas, our growing CPD Certification Centre and extensive member benefits.

Like our members, we have a keen eye on the future and have contributed significant resources in setting up a sector-leading Internet of Things Forum that is made up of over 60 FIA members and is attended by key industry stakeholders such as BSI, BRE, BSIA, Euralarm and others from outside the fire industry. We look forward to developing this Forum and giving our industry a great platform to discuss, collaborate and provide tangible results on this important topic. We have also continued to make steady progress with the Electronic Call Handling Operations (ECHO) project that we started with BSIA and ECA; we're now working with the NFCC to create a 5-year vision document that lays out what is needed to bring ECHO into the fire industry and look forward to working with our members to make this a reality.

This year's Annual Report provides an insight into how we have continued to make significant progress to improve the fire industry in spite of the challenges that we have all faced together as an industry. Whilst this report highlights the considerable work that we have achieved, we know that our work must continue to evolve. The immediate focus is to continue to work as hard as ever on the three key issues of Covid-19, Brexit and Grenfell until there is nothing left to work on in these areas.

Finally, a few words of thanks to the Board, Councils and numerous Working Groups and SIGs who I sincerely thank for giving up their time for no financial reward. They are more committed than ever by stepping up their involvement in a number of areas to the challenges the FIA and fire industry is facing. This gives a stronger base of expertise for me as the Chief Executive Officer (CEO) to draw on.

I am proud of the immense commitment of the FIA Secretariat. Our membership, training and technical teams continue to be outstanding in a number of areas, our marketing team consistently delivers strong messages and our unheralded back-room staff (such as finance, compliance and operations) are also to be commended. We look forward to the year ahead with apprentices joining us which will enable us to do more for our members and the industry.

# Membership

The last 12 months have by no short measure seen the largest number of companies coming into membership in the history of the association.

For example, in the last 12 months 161 companies have come into membership. That is a 100% increase on the previous year when we saw 80 companies join in the same period.

Not only are more companies joining, less are leaving as well. During the last 12 months, 64 companies left membership for various reasons. When compared against the previous year during which 72 companies left membership, we are left with a total gain during this period of 97 new members compared to only 8 in the previous period, representing a 1200% increase year-on-year.

Further, we have a long-standing target of reaching 1000 member companies. We are expecting to achieve this sometime during Sept/Oct 2021.



# Membership Initiatives

Throughout the last year we have been working on a number of initiatives to continuously improve our offering to our members.

# **§lgneo**

During the last year we have partnered with Igneo and have actively participated in the development of their platform. Igneo's mission is to be the single point of reference for compliance and competence for the UK Fire Safety Industry.

By consolidating publicly available data onto one central, searchable online database, Igneo have made it easier than ever for companies to prove their various competency's, certifications and insurances and also help procurement end users to select companies who are correct for the task at hand.

As this message ties in so closely with the FIA's core values and membership criteria, there was no question that we should be at the heart of this new service for the industry. As a result, FIA members have had first access to start claiming their listings and completing their profiles. So far over 100 member companies have taken advantage of the platform.

We would encourage all of our member to go to **Igneo.co.uk** and claim their company listing.



# **FIA CPD Certification Service**

The FIA CPD certification was originally launched in June 2020. Since then we have assessed and certified over 120 hours of CPD presentations for 50 member companies. This service is free of charge at the point of assessment and certification.

We have further expanded the offer to enable member companies to run their CPD sessions via the FIA for a small fee which enables us to cover any associated costs. For £250 members can:

- Use our Zoom platform and booking management system
- Utilise FIA marketing to 29,000 fire professionals on LinkedIn to promote their sessions
- Have certification issued directly from the FIA for all attendees (up to 500)

This service has enabled many members to save thousands of pounds on certification fees for their presentations whilst increasing their audience.

This year has seen a continual focus on improving the portfolio of third-party benefits available to FIA members. # Compliance

Here are a few facts over the last year:

Currently there are 78 probationary members as part of the overall membership as at 12 Aug 21. In spite of the pandemic, 44 companies have achieved 3rd Party Certification since the last report, of which 16 were under the Route to

Certification package.

Currently there are 44 companies on the RTC package, to achieve certification over the next 6 to 12 months. We continue to work with BSi, NSI & SSAIB (and Certsure on occasion), on achieving the various certifications, of which all have been BAFE certifications to date.

Compliance was no different than other departments in the FIA, in the sense that, the last year has provided unprecedented obstacles. Consequently, we have had to be flexible and adapt to our customers changing needs and the world around us in order to turn these obstacles into opportunities. We have worked hard to ensure our Route to Certification scheme has the same high level of quality; as a result, we have used the latest technology and adapted the scheme alongside new social-distancing rules.

# Training



Despite the instability Covid-19 has caused throughout the UK over the last 12 months, the FIA have continued to evolve training in order to meet the needs of a diverse range of companies and their delegates, both members and non-members. We at the FIA, ran a mixture of online and classroom-based courses while always keeping an eye and an ear on what was happening in the world, ensuring we remained adaptable. Some courses were cancelled at the last minute and moved online to ensure delegates still received the training required in spite of an unpredictable world. In addition to this, we were tasked with overcoming last minute cancellations from companies, in these instances the FIA tried to facilitate changes that were required. Finding our way through this challenging period was a great team effort by all involved. The FIA would like to thank all the companies and delegates for their patience and understanding over this period.

The new normal for FIA Training has seen us implement a selection for both online and in classroom training options. 24 out of our 28 courses (86%) are available online as we continue to migrate our portfolio onto an online platform.

3 new courses were introduced in the last year with another course being revamped. We continue to develop current courses in addition to looking at new potential partners to work with in widening the range of courses we offer to the industry.

The ongoing challenge for the FIA will always be developing and improving the training we offer to the industry. We acted on this when one company asked for a specific course; this led to the delivery of the Fire Protection for Electronic Equipment Installations to BS 6266 course. This is FIA training at its best, the industry asks, we listen and produce inudstry-leading training that allows delegates to continue their journey to become a more competent fire professional.

The FD&A Qualification courses continue to be the market leader for the FIA, at the end of July we saw the delivery and registration of these exams move over to FIREQUAL following the sale of the FIA Awarding Organisation to BAFE. The key part of this process has been to make sure there was no disruption to delegates partway through their qualification process, this was a great success.

The BS 5839-1 Fundamentals in FD&A Qualification is now the go to qualification for those looking to cover this subject matter. With a new course in place to allow those who have qualified to start the process towards the Advanced Qualifications, the FIA provides a pathway for all delegates, no matter their experience.

2021 to 2022 will prove to be as challenging as the last 12 months. FIA Training is determined to keep its place as the leading training provider in the industry while also looking to add more courses, improve its portfolio and continue to educate and enhance the knowledge and skill of all fire professionals we interact with at the Fire Industry Association.

# Marketing

In 2021 the marketing team focussed on engaging and responding to the industry's needs. We have promoted of the newly established EWS1 portal, reinforced our visibility as the top provider of news for the fire industry through conveying all vital updates to ensure that fire industry is up-to-date with the latest governmental guidance and regulatory amendments and improved the way our content is distributed and displayed across all mediums.



#### FIA Website and Systems

In 2021, we conducted an end to end audit of all of the FIA systems. With the support of the experts, we have evaluated the effectiveness of the current processes within the existing FIA systems. Auditing FIA systems' processes has allowed in the short term to improve our current processes and in the long term look to create new ways of working that help the FIA achieve our key objectives as an organisation.

We are currently in the process of significantly upgrading the functionality of our website which will greatly improve the user experience of the website.

What's more, we have continued to experience good levels of website traffic seeking clarifications of the current government regulations for the fire industry.





Every year, we look to improve the quality of the content in our E-communication and the format of the content to make it as user friendly as possible. Fireside Chats, which highlight the variety of roles and people within the industry to others currently in the industry, have been introduced as the headline piece for each Focus which has been well received and engaged with by our members and the wider industry.

When it comes to the Training email, we have improved the format to give it a similar feel to the layout of the training section of our website, this has given our readers more familiarity with the email and has been shown in the increase engagement compared to its previous format.

Many of you will be aware that we created the Monthly Membership Update last year which has continued to provide our members with exclusive member benefits, key industry news and highlights to our members the ample opportunities they can take advantage of.

## **Social Media**

We have seen continued growth in followers across all FIA social media platforms the last year. Our biggest increase in followers is on LinkedIn, arguably the most important channel outside of our website and e-communication. We have cemented ourselves as the market leader in the European market (and rank second globally) with 29,082 followers and in the last year we have once again gained over 7619 new followers which is a 36% growth – shown in the below table.





The unprecedented circumstances brought in by the pandemic have forced us to postpone once again our Spring 2021 edition of FIM Expo event in Northern Ireland took place on the 19th October. Also, FIREX International event that was scheduled for mid-July in London Excel was sadly postponed again to May 2022.

Our iconic 2021 AGM & Lunch is scheduled to take place on the 11 of November 2021 and we are looking forward to providing our members and their guests with a memorable experience and opportunity for real life interaction with the other fire industry members.





Research



Every year in the Spring, we hold a unique survey which looks at the Impact of Brexit on the Fire Industry. This survey was aimed at the fire industry professionals who provided us with the vital data on how Brexit has affected their organisation both now and, in the years to come.

As with every October, we released our Market Conditions Survey, where we found that has found that our resilient industry has continued to not only overcome the challenges we have faced, but grown and developed in a sustainable fashion.

#### **Public Relations**

Our CEO has had a very busy year ensuring the FIA membership is well represented in as many relevant areas as possible. With Brexit, the pandemic and finalisation of a number of pieces of important Government legislative changes, this liaison work has been undertaken with Home Office, MHCLG, All Party Parliamentary Groups, Competency Steering Groups, BAFE, Fire Sector Federation, NFCC and many more.

Brexit work has centred around the change from CE marking to the UKCA marking and the lack of time and resource to implement it. We are pleased to say that our continuous engagement with various Government departments has led to them extending the deadline to be more realistic for our industry.

The pandemic continued to create a number of challenges for the FIA and our members. Our experience to engage online has worked well for us (training, CPD, meetings etc) and our members continued to benefit from Key Worker status during the lockdown to carry out life safety work.

Finally, most of the liaison work with the above-mentioned bodies has been associated with the need for change following the Grenfell Tower reports (e.g., Fire Safety Bill, Building Safety Bill etc). We continue to work with the above-mentioned strategic partners to make the fire industry better, safer and more competent.

## **Customer Engagement**





In the 'post-Grenfell era', the severity and lethality of the fire at Grenfell Tower was found to be largely caused by the external cladding on the building which caused rapid spread of the fire from its source on the 4th floor of the 24 storey block in West London.

This brought the dreadful realisation that there were many other residential buildings throughout the nation that also featured cladding that may promote fire spread and that these must urgently be identified and remedial action taken. It has also precipitated deep uncertainty and despair among flat owners and potential buyers, with many owners unable to sell their properties subject to determining whether their home is able to go on the market and for buyers to obtain a mortgage.

So-called EWS-1 forms were developed by the Royal Institution of Chartered Surveyors [RICS] as a means of enabling competent fire experts to record whether buildings are fire safe in respect of their external cladding and, if not, that remedial work must be carried out. The provision of these forms has proved successful in creating clear and consistent documentation in this respect.

In order to create a fully reliable and accessible process for the upload and retrieval of these forms, the FIA stepped in to meet this requirement. In consultation with MHCLG and in collaboration with RICS and other stakeholders including lenders and insurers, it developed a unique portal with software specialists Twine79 that since November last year provides a central readily-accessible location for EWS-1 forms and, for the first time, the ability for suitably qualified experts to complete the forms on-line.

Signatories to EWS-1 forms must first register to submit or complete forms on-line and provide evidence of applicable professional memberships and qualifications prior to the application being approved. Buyers, sellers, lenders, insurers and others having an interest in particular properties can search for buildings by postcode or building name, after which the form, if on the Portal, will appear with its full postal address. The form can then be viewed and downloaded free of charge.

The web site is named the Building Safety Information Portal [BSIP] and may be found at **buildingsafetyportal.co.uk**, this reflecting its future potential to act as a reliable repository for a wide range of building safety documentation including, for example, a list of approved assessors for EWS evaluations, full EWS Reports and whole building Fire Risk Assessments.

Of special importance is the need to prevent fraudulent activity relating to EWS-1 forms and so a rigorous approach has been applied to the Portal to include manual checks at various stages of the process. Each Fire Engineer wishing to submit forms must present evidence that they are fully qualified and competent to do so and this is interrogated prior to enabling their forms to be submitted to the Portal. In addition, all existing forms and on-line submissions are subject to further checks to determine their validity before they appear as publicly-available documents.

The development of the Portal proved a significant challenge in creating an easy-to-use platform from a standing start and doing so as rapidly as possible. It has also been subject to revision since its launch to reflect recent developments based on government advice, the resulting RICS Guidance and indeed the release in early April of a revised EWS-1 form. More development work is on the horizon as we address further changes in the domestic housing sector.

The FIA's work in this area is, and will remain, an invaluable tool for homeowners, prospective buyers, valuers and lenders as well as the EWS assessors themselves and plays a vital role in re-establishing buying and selling transactions for flats in multi-story buildings.

## **Fire Risk Assessment Council**





The Fire Risk Assessment Council has been busy this year with Zoom being an invaluable resource due to the vast restrictions the pandemic enforced. We responded to the Grenfell Tower Inquiry: Phase 1 Report and aided the Government in implementing its recommendations. In addition to this we responded to the government consolations on: Personal Emergency Evacuation Plans PEEPS, Domestic Smoke and Carbon Monoxide Alarms: proposals to extend regulations, as well as Fire Safety Guidance overhaul.

The Council has worked with the British Standards Institute on several standards including: PAS 79 parts 1 & 2 and PAS 9980. It has worked with the Industry Response Working Group 4 on a new code of practice for risk assessments on HRRBs and produced a myth buster on 'Do I need to redo the fire risk assessment on my premises every year?'. Furthermore, the Fire Risk Assessment Council has worked with the NFCC on a new code of practice for Premises Information Boxes PIBs and produced Guidance on Fire Procedures During the Covid-19 Pandemic.

## **Fire Engineering Council**



The Fire Engineer council has been busy this year in response to the Grenfell Tower Inquiry: Phase 1 Report. We also responded to the government consolations on: Personal Emergency Evacuation Plans PEEPS and Fire Safety Guidance overhaul. The Council has been working with RICS on the development of the EWS-1 form and its implementation. In addition to this we also formed a Special Interest Group in conjunction with the IFE on Façades and are holding webinars to promote and inform members of its work.

## **FIRESA Council**





Representing our suppliers to the Fire and Rescue sector, we continue to expand our involvement within the FR landscape and beyond to the wider fire safety environment. Liaising with a number of government departments, the NFCC and a host of other stakeholders, we are able pro-actively to contribute to and influence the changes occurring in the sector. Notable current projects include procurement, product innovation and firefighter safety.
