Letter from the Euralarm President

Dear Member of Euralarm, Dear Delegate to the Section,

Half of the 'Euralarm Business year' has already gone and the new Board and other teams have been in charge for more than the symbolic 100 days. In this newsletter we want to report on what has happened since the last one was sent out, in July 2015, and to give you an outlook on the future. Activities of the Board

The Euralarm Board has convened in its new composition, in one physical meeting and two web conferences. Main topics have been, and remain, the transformation of the Euralarm Office and the new organisation of Euralarm. We are happy to report good progress and successes.

The accounting process has been successfully transferred to a professional accounting company in Brussels and we are close to concluding a contract for secretarial services.

The most important news however is the conclusion of a contract with our new Communications Manager, Piotr Pogorzelski, who began to work for Euralarm on October 1st, 2015.

Nevertheless, there remains a lot to do to prepare Euralarm for a successful future.

Highlights from the Fire Section

In 2012, Euralarm took part in an EU Commission workshop, which resulted in a call for an EU approach to fire safety and security in tourism accommodation.

Since then, we have outlined our position with <u>two letters to DG SANCO</u> (2013), <u>a Euralarm briefing paper</u> (2013), answers to two EU Commission consultations (2012 and 2014), and several <u>press articles</u>.

Numerous meetings with stakeholders included high-level EU representatives, the European Consumers Association, the European Sprinkler Industry Association, and others. They were also invited to the 2014 Conference held during the Euralarm annual assembly.

Persistence did pay off! In September, an EU Parliament Committee voted the adoption of a report calling on "the Commission to come forward with proposals for minimum standards for tourism safety in the EU, in particular in the area of fire safety and carbon monoxide safety." Euralarm issued a <u>Communiqué</u> ahead of the voting of the report in plenary by end 2015.

EU legislation for fire and CO safety in accommodation is not yet at hand, but Euralarm is now a key interlocutor for Brussels.

Highlights from the Services Section

Recent months have seen the votes and comments on the Services standard EN 16763, unfortunately the 2-day meeting in Berlin in September was not enough to finalise the review of the comments and another 2-day meeting is scheduled for November, where it is hoped that an agreement will be found and the document moved to the next stage.

Following the standards meeting, Euralarm hosted an open stakeholder meeting with third party certification bodies. The object of this meeting was to try and align the thoughts of third party certification bodies, in the way in which they would certify companies (our members) to meet EN 16763 criteria. I am however disappointed to say that we did not manage to make any progress in this area and I fear now that different certification bodies will have different interpretations as to how an organisation can meet this new and important standard for our industry. Clearly this will be on the agenda for the next meeting of the section.

TC Advocacy

The committee has been re-focusing its efforts and energy into augmenting and further improving our advocacy impact. Until the end of 2015, we will have a new policy programme under the name "Our Manifesto for a Safer and more Secure Europe 2016 – 2019". The new document is lighter in text, but very clear in what our topics are and the requests we have for policy makers and legislators. The launch of the Manifesto will be beginning of 2016 with a number of activities to increase the overall effect.

Other main activities have been to build up a list of champions in the European Parliament and European Commission. Our network into these bodies is important and something we need to continually develop and manage.



Our contract with Burson-Marsteller, an advocacy consultancy, will end on March 31st, 2016. Until then we will work on providing an advocacy manual and some form of training. Details will be available as we develop the programme.

European Standardisation activities - Meeting with CCMC on October 5th, 2015

Recently there has been considerable activity in the area of standardisation and Euralarm has been very active in contributing to the many workshops.

In July the EU Commission, DG GROW, held a 'Roundtable meeting' to capture the industry's opinions on 'governance, interaction and communication' of the European Standardisation System – this following an Ernst & Young study realised and published on behalf of the EU Commission. Euralarm attended and gave input at both these meetings.

Subsequently, CEN-CENELEC held a workshop on 'Strengthening CEN and CENELEC engagement with European industry' on October 5th, to which Euralarm had a strong representation. This was followed up with a more detailed and practical discussion with CCMC – the CEN-CENELEC Management Centre - on the various issues impacting efficiency in releasing standards. The second meeting was as a direct follow up from our Market Driven Standardisation report, the CCMC response and Elena Santiago's attendance at our General Assembly.

Finally, we have been invited by CEN-CENELEC, as "one of Europe's influential bodies involved in standardisation," to contribute in developing recommendations for a Pact on European standardisation to strengthen the public-private partnership and contribute actively to relevant priorities defined by the EU Commission's political leadership.



Euralarm is now clearly active in the many areas of standardisation – in policy, discussions on efficiency, as well contributing to the creation of relevant standards.

Outlook until the year end

As you have seen, even during the summer period, Euralarm has been active. Good progress has been made in many areas and there is more to come.

By the beginning of the year 2016, we expect the publication of a legislative proposal from DG HOME on the 'Certification of Security Products' as was announced by European Commission's Kristien van Goey at our Symposium in Vienna. We believe that it will go in a direction that is positive for our industry. As soon as the proposal is published we need to start an advocacy campaign with Members of the European Parliament to gain positive influence in the parliamentarian debate. We will let you know more about this topic in due time.

In parallel, the Board will continue to work on the internal matters subsequent to the General Assembly 2015 in Vienna and the feedback we have received from some of the members on my request to comment on the statutes. The next meeting of the Board in December will be dedicated to discussing next steps on the revision of the statutes. However, before we can work seriously on the statutes the Board needs to decide how it wants to proceed with the request that the legal seat of Euralarm shall be moved to Brussels.

We will keep you informed on this and all other activities.
